

## THANK YOU CENTRAL NEW YORK SWEEPSTAKES

### OFFICIAL RULES

**If you participate via mobile device, message and data rates may apply.**

#### 1. ELIGIBILITY:

A. **NO PURCHASE IS NECESSARY TO ENTER OR CLAIM A PRIZE. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.** Thank You Central New York Sweepstakes (“Sweepstakes”) is open to legal residents of the fifty (50) United States and the District of Columbia, age eighteen (18) years or older at the time of entry, except employees, their spouses and immediate families (*i.e.*, parent, child, sibling and any of their respective spouses) and household members (whether or not related) of Chick-fil-A (“Sponsor”), IMG College, LLC (“Administrator”), Syracuse University Department of Athletics (“Syracuse”), and each of their respective parent, subsidiaries, divisions, trustees, franchisees, participating vendors, distributors, cable affiliates, advertising and promotion agencies and affiliated entities (collectively, including Sponsor, “Sweepstakes Entities”).

B. This Sweepstakes is governed by United States law and subject to all applicable federal, state and local laws and regulations. By entering this Sweepstakes, each entrant agrees to accept and be bound by all terms of these Official Rules (herein so called). Void where prohibited by law.

#### 2. HOW TO ENTER:

A. From 12:01:00 am Eastern Time (“ET”) on January 5, 2022, through 11:59:59 pm ET on January 19, 2022 (“Entry Period”), Sponsor and Administrator will conduct a Sweepstakes encouraging participants to enter for a chance to win a prize. There is one (1) way to enter the Sweepstakes:

Each entrant will receive one (1) entry for his/her qualified registration. To be eligible, each entry must be received no later than 11:59:59 pm ET January 19, 2022. **LIMIT ONE (1) ENTRY PER PERSON.**

B. Any entry generated by script, macro or other automated means will be void. Sweepstakes Entities are not responsible for misdirected, incomplete, lost, late, illegible, undelivered, inaccurate or delayed entries, or for technical, hardware or software failures of any kind, lost or unavailable network connections or failed, incomplete, garbled or delayed computer transmissions or other errors or problems that may limit or affect an individual’s ability to participate in this Sweepstakes, whether human, mechanical, typographical, printing, electronic, network or otherwise, relating to or in connection with this Sweepstakes, including, without limitation, errors that may occur in connection with the administration of this Sweepstakes, the processing of entries, the announcement of the prizes or in any Sweepstakes-related materials. In the event of sabotage, acts of God, terrorism or threats thereof, computer virus or other events or causes beyond Sponsor’s control, which corrupt the integrity, administration, security or proper operation of this Sweepstakes, Sponsor reserves the right, in its sole discretion, to disqualify an entrant and/or modify, cancel or suspend this Sweepstakes. In the event of cancellation, Sponsor reserves the right to award prizes from among all eligible, non-suspect entries received prior to the cancellation-requiring event. ### **3. HOW TO WIN:**

A. On or around January 20, 2022, one (1) potential winners (when verified by Sponsor and Administrator as set forth below, "Winner") will be selected in a random drawing from all eligible entries received during the Entry Period.

The potential Winners will be notified by Sponsor or Administrator via email and/or telephone and must meet all eligibility requirements, including timely replying to the notification and timely executing and returning all necessary releases and documents (if any) required by Sponsor and/or Administrator. Winning a prize is contingent upon fulfilling all requirements set forth in these Official Rules. Odds of winning depend on the number of eligible entries received.

B. If there is a dispute as to the Winner's identity, then the winning entry will be declared to have been made by the authorized email account holder at time of entry. A potential Winner will be disqualified, the prize will be forfeited and an alternate potential Winner will be selected by an alternate random drawing from among all remaining eligible entries and an alternate Winner may be selected at Sponsor's sole and absolute discretion if (i) any prize notification is returned as undeliverable, (ii) a potential Winner declines his/her prize, (iii) a potential Winner fails to comply with any of the Official Rules or (iv) a potential Winner does not respond to the notification or accept the prize within twelve (12) hours.

The Winner will receive from Sponsor (i) two (2) tickets to the Syracuse men's basketball regular-season away game at Boston College, in Boston, MA, on February 8, 2022 ("Game"), (ii) one (1) double occupancy hotel room at the AC Boston Hotel Cleveland Circle, for the Winner and one (1) guest, for two (2) nights (February 7, 2022 (check in), and February 8, 2022 (with checkout on February 9, 2022)) and (iii) round-trip airfare for the Winner and one (1) guest from Syracuse, NY, to Boston, MA. No substitution of airports for roundtrip flights is permissible. If the Winner or guest misses the initial flight, as scheduled, then Administrator will exercise reasonable efforts to provide replacement transportation, but the Winner and/or guest run the risk of forfeiting the Prize. If the Winner or guest is not present for the designated return flight, then such individual(s) will be solely responsible for another return flight. If either flight is cancelled due to unforeseen events, Administrator will exercise best efforts to provide the Winner and guest alternative transportation as a replacement for the canceled flight.
