

SYRACUSE ATHLETICS RESTAURANT PARTNERS SWEEPSTAKES

OFFICIAL RULES

If you participate via mobile device, message and data rates may apply.

1. ELIGIBILITY:

A. **NO PURCHASE IS NECESSARY TO ENTER OR CLAIM A PRIZE. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.** Syracuse Athletics Restaurant Partners Sweepstakes (“Sweepstakes”) is open to legal residents of the fifty (50) United States and the District of Columbia, age eighteen (18) years or older at the time of entry, except employees, their spouses and immediate families (*i.e.*, parent, child, sibling and any of their respective spouses) and household members (whether or not related) of 110 Grill, Attilio’s, Brian’s Landing, Carrabba’s Italian Grill, Heritage Hill Brewery, Home Team Pub, Meier’s Creek brewing Company, Margarita’s Mexican Cantina, Prime Steakhouse or San Miguel Mexican Bar & Grill (each, a “Sponsor”; collectively, “Sponsors”), IMG College, LLC (“Administrator”), Syracuse University Department of Athletics (“Syracuse”), and each of their respective parent, subsidiaries, divisions, trustees, franchisees, participating vendors, distributors, cable affiliates, advertising and promotion agencies and affiliated entities (collectively, including Sponsors, “Sweepstakes Entities”).

B. This Sweepstakes is governed by United States law and subject to all applicable federal, state and local laws and regulations. By entering this Sweepstakes, each entrant agrees to accept and be bound by all terms of these Official Rules (herein so called). Void where prohibited by law.

2. HOW TO ENTER:

A. From 12:00:01 am Eastern Time (“ET”) on August 15, 2022, through 11:59:59 pm ET on Saturday, June 30, 2023 (“Entry Period”), Sponsors and Administrator will conduct a Sweepstakes encouraging participants to enter for a chance to win a prize. There is one (1) way to enter the Sweepstakes:

Each entrant will receive one (1) entry for his/her qualified registration. To be eligible, each entry must be received no later than 11:59:59 pm ET on Saturday, June 30, 2023. **LIMIT ONE (1) ENTRY PER PERSON PER MONTH.**

B. Any entry generated by script, macro or other automated means will be void. Sweepstakes Entities are not responsible for misdirected, incomplete, lost, late, illegible, undelivered, inaccurate or delayed entries, or for technical, hardware or software failures of any kind, lost or unavailable network connections or failed, incomplete, garbled or delayed computer transmissions or other errors or problems that may limit or affect an individual’s ability to participate in this Sweepstakes, whether human, mechanical, typographical, printing, electronic, network or otherwise, relating to or in connection with this Sweepstakes, including, without limitation, errors that may occur in connection with the administration of this Sweepstakes, the processing of entries, the announcement of the prizes or in any Sweepstakes-related materials. 3. HOW TO WIN:

A. On or around the fifth day of each month during the Entry Period, one (1) potential winner (when verified by the applicable Sponsor and Administrator as set forth below, "Winner") will be selected in a random drawing from all eligible entries received.

Each potential Winner will be notified by the applicable Sponsor or Administrator via email and/or telephone and must meet all eligibility requirements, including timely replying to the notification and timely executing and returning all necessary releases and documents (if any) required by the applicable Sponsor and/or Administrator. B. THE TOTAL APPROXIMATE RETAIL VALUE OF EACH PRIZE IS TWENTY-FIVE DOLLARS (\$25.00)—TWO HUNDRED SEVENTY-FIVE DOLLARS (\$275.00) IN TOTAL (FOR ALL ELEVEN (11) GIFT CARDS).

C. No substitution or transfer of the prize or cash redemption is permitted. Each Sponsor reserves the right to substitute a prize (or any portion thereof) of comparable or greater value, in its sole discretion.

D. Each Winner is responsible for the reporting and payment of all federal, state and local taxes (if any) and any other costs and expenses associated with prize acceptance and use not specified in these Official Rules and/or in the applicable entry instructions as being provided. The prize will be fulfilled within a reasonable time of the applicable Sponsor's or Administrator's Winner
