

**PATHFINDER BANK WIN AN AUTOGRAPHED BASKETBALL BY HEAD MEN'S
BASKETBALL COACH JIM BOEHEIM SWEEPSTAKES**

OFFICIAL RULES

If you participate via mobile device, message and data rates may apply.

1. ELIGIBILITY:

A. **NO PURCHASE IS NECESSARY TO ENTER OR CLAIM A PRIZE.
