

# CHICK-FIL-A TEACHER APPRECIATION SWEEPSTAKES

## OFFICIAL RULES

**If you participate via mobile device, message and data rates may apply.**

### 1. ELIGIBILITY:

A. **NO PURCHASE IS NECESSARY TO ENTER OR CLAIM A PRIZE. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.** Chick-Fil-A Teacher Appreciation Sweepstakes (“Sweepstakes”) is open to legal residents of the fifty (50) United States and the District of Columbia, age eighteen (18) years or older at the time of entry, except employees, their spouses and immediate families (*i.e.*, parent, child, sibling and any of their respective spouses) and household members (whether or not related) of Chick-fil-A (“Sponsor”), IMG College, LLC (“Administrator”), Syracuse University Department of Athletics (“Syracuse”), and each of their respective parent, subsidiaries, divisions, trustees, franchisees, participating vendors, distributors, cable affiliates, advertising and promotion agencies and affiliated entities (collectively, including Sponsor, “Sweepstakes Entities”).

B. This Sweepstakes is governed by United States law and subject to all applicable federal, state and local laws and regulations. By entering this Sweepstakes, each entrant agrees to accept and be bound by all terms of these Official Rules (herein so called). Void where prohibited by law.

### 2. HOW TO ENTER:

A. From 12:01:00 am Eastern Time (“ET”) on November 1, 2022, through 11:59:59 pm ET on December 1, 2022 (“Entry Period”), Sponsor and Administrator will conduct a Sweepstakes encouraging participants to enter for a chance to win a prize. There is one (1) way to enter the Sweepstakes:

Each entrant must visit <https://contests.cuse.com/campaigns/5c367734-0fe5-4c8c-b91a-5c8b257e28f7/teacher-appreciation-contest> (“Website”) and follow the instructions thereon to complete and submit the on-line form, including the entrant’s name, address, telephone number, date of birth, email address and any other information requested on the form (including a teacher nominee’s first name, last name, school and school telephone number). Each entrant will receive one (1) entry for his/her qualified registration. To be eligible, each entry must be received no later than 11:59:59 pm ET December 1, 2022. **LIMIT ONE (1) ENTRY PER PERSON.**

B. Any entry generated by script, macro or other automated means will be void. Sweepstakes Entities are not responsible for misdirected, incomplete, lost, late, illegible, undelivered, inaccurate or delayed entries, or for technical, hardware or software failures of any kind, lost or unavailable network connections or failed, incomplete, garbled or delayed computer transmissions or other errors or problems that may limit or affect an individual’s ability to participate in this Sweepstakes, whether human, mechanical, typographical, printing, electronic, network or otherwise, relating to or in connection with this Sweepstakes, including, without limitation, errors that may occur in connection with the administration of this Sweepstakes, the processing of entries, the announcement of the prizes or in any Sweepstakes-related materials. ### **3. HOW TO WIN:**

A. On or around December 5, 2022, ten (10) total potential winners (when verified by Sponsor and Administrator as set forth below, "Winner") will be selected in a random drawing from all eligible entries received during the Entry Period – two (2) grand prize Winners and eight (8) secondary prize Winners.

The potential Winners will be notified by Sponsor or Administrator via email and/or telephone and must meet all eligibility requirements, including timely replying to the notification and timely executing and returning all necessary releases and documents (if any) required by Sponsor and/or Administrator. Winning a prize is contingent upon fulfilling all requirements set forth in these Official Rules. Odds of winning depend on the number of eligible entries received.

B. If there is a dispute as to the Winner's identity, then the winning entry will be declared to have been made by the authorized email account holder at time of entry. Each grand prize Winner will receive (i) two (2) tickets to the Syracuse men's basketball regular-season home game vs. Boston College on either December 30 or 31, 2022 (time TBD) ("Game") (four (4) total tickets), and (ii) a Sponsor-catered meal at his/her school (two (2) total meals).

B. SECONDARY PRIZES. Each secondary prize Winner will receive two (2) tickets to the Game (sixteen (16) total tickets).

B. THE TOTAL APPROXIMATE RETAIL VALUE ("ARV") OF THE PRIZES IS THREE THOUSAND THREE HUNDRED NINETY-EIGHT DOLLARS (\$3,398.00)—ONE HUNDRED DOLLARS (\$100.00) PER GAME TICKET (TWENTY (20) TOTAL TICKETS) AND SIX HUNDRED NINETY-NINE DOLLARS (\$699.00) PER CATERED MEAL (TWO (2) TOTAL CATERED MEALS).

D. No substitution or transfer of the prize or cash redemption is permitted. Sponsor reserves the right to substitute a prize (or any portion thereof) of comparable or greater value, in its sole discretion.
