

# CNY CHEVY GAMEDAY GIVEAWAY SWEEPSTAKES

## OFFICIAL RULES

**If you participate via mobile device, message and data rates may apply.**

### 1. ELIGIBILITY:

A. **NO PURCHASE IS NECESSARY TO ENTER OR CLAIM A PRIZE. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.** CNY Chevy Gameday Giveaway Sweepstakes (“Sweepstakes”) is open to legal residents of the fifty (50) United States and the District of Columbia, age eighteen (18) years or older at the time of entry, except employees, their spouses and immediate families (*i.e.*, parent, child, sibling and any of their respective spouses) and household members (whether or not related) of Central New York Chevy Dealers (“Sponsor”), IMG College, LLC (“Administrator”), Syracuse University Department of Athletics (“Syracuse”), and each of their respective parent, subsidiaries, divisions, trustees, franchisees, participating vendors, distributors, cable affiliates, advertising and promotion agencies and affiliated entities (collectively, including Sponsor, “Sweepstakes Entities”).

B. This Sweepstakes is governed by United States law and subject to all applicable federal, state and local laws and regulations. By entering this Sweepstakes, each entrant agrees to accept and be bound by all terms of these Official Rules (herein so called). Void where prohibited by law.

### 2. HOW TO ENTER:

A. From 12:01:00 am Eastern Time (“ET”) on January 18, 2023, through 11:59:59 pm ET on February 1, 2023 (“Entry Period”), Sponsor and Administrator will conduct a Sweepstakes encouraging participants to enter for a chance to win a prize. There is one (1) way to enter the Sweepstakes:

Each entrant will receive one (1) entry for his/her qualified registration. To be eligible, each entry must be received no later than 11:59:59 pm ET on Sunday, February 1, 2023. **LIMIT ONE (1) ENTRY PER PERSON.**

B. Any entry generated by script, macro or other automated means will be void. Sweepstakes Entities are not responsible for misdirected, incomplete, lost, late, illegible, undelivered, inaccurate or delayed entries, or for technical, hardware or software failures of any kind, lost or unavailable network connections or failed, incomplete, garbled or delayed computer transmissions or other errors or problems that may limit or affect an individual’s ability to participate in this Sweepstakes, whether human, mechanical, typographical, printing, electronic, network or otherwise, relating to or in connection with this Sweepstakes, including, without limitation, errors that may occur in connection with the administration of this Sweepstakes, the processing of entries, the announcement of the prizes or in any Sweepstakes-related materials. In the event of sabotage, acts of God, terrorism or threats thereof, computer virus or other events or causes beyond Sponsor’s control, which corrupt the integrity, administration, security or proper operation of this Sweepstakes, Sponsor reserves the right, in its sole discretion, to disqualify an entrant and/or modify, cancel or suspend this Sweepstakes. ### **3. HOW TO WIN:**

A. On or around February 3, 2023, one (1) potential winner (when verified by Sponsor and Administrator as set forth below, "Winner") will be selected in a random drawing from all eligible entries received during the Entry Period.

The potential Winner will be notified by Sponsor or Administrator via email and/or telephone and must meet all eligibility requirements, including timely replying to the notification and timely executing and returning all necessary releases and documents (if any) required by Sponsor and/or Administrator. Winning a prize is contingent upon fulfilling all requirements set forth in these Official Rules. Odds of winning depend on the number of eligible entries received.

B. If there is a dispute as to the Winner's identity, then the winning entry will be declared to have been made by the authorized email account holder at time of entry. A potential Winner will be disqualified, the prize will be forfeited and an alternate potential Winner will be selected by an alternate random drawing from among all remaining eligible entries and an alternate Winner may be selected at Sponsor's sole and absolute discretion if (i) any prize notification is returned as undeliverable, (ii) a potential Winner declines his/her prize, (iii) a potential Winner fails to comply with any of the Official Rules or (iv) a potential Winner does not respond to the notification or accept the prize within twelve (12) hours.

A. The Winner will receive four (4) tickets to the Syracuse vs. North Carolina State University home men's basketball game on February 14, 2023 (time TBD) as well as one (1) parking pass.

B. THE TOTAL APPROXIMATE RETAIL VALUE OF THE PRIZE IS THREE HUNDRED SEVENTY-FIVE DOLLARS (\$375.00)—THREE HUNDRED SIXTY DOLLARS (\$360.00) FOR THE TICKETS AND FIFTEEN DOLLARS (\$15.00) FOR THE PARKING PASS.

C. No substitution or transfer of the prize or cash redemption is permitted. Sponsor reserves the right to substitute a prize (or any portion thereof) of comparable or greater value, in its sole discretion.

D. The Winner is responsible for the reporting and payment of all federal, state and local taxes (if any) and any other costs and expenses associated with prize acceptance and use not specified in these Official Rules and/or in the applicable entry instructions as being provided. The prize will be fulfilled within a reasonable time of Sponsor's or Administrator's Winner verification. All prize details and additional terms, conditions or eligibility requirements are in Sponsor's and/or Administrator's discretion.
